4. Meeting open to the public

John Sheridan from DPD, although he contacted the Clerk to ask if he could come and speak to the Councillors about vehicles in the village and community involvement, did not attend the meeting.

5. Report of County Councillor: J Spicer

Cllr Spicer was unable to attend the meeting.

6. Report from B. Councillor: C Bull

Cllr Bull was unable to attend the meeting but sent the following report: St Edmundsbury and Forest Heath are looking at forming one Council. To date both cabinets are supporting this and it will be going to both Full Councils shortly. I will update you on progress and what it all means at the next meeting.

The West Suffolk Waste Hub planning application will be going to full committee at an extraordinary Planning Committee meeting on 19th July.

I note that the first successful St Edmundsbury prosecution for dog fouling was in relation to an incident in Barningham!

Work has started on upgrading the Cullum Road/parkway roundabout in Bury and there is likely to be severe disruptions particularly at peak times for some months

I am pleased to report that the Hepworth Road planning application has been allowed but with the house setback to be less overbearing and with obscured glass in the side window in response to some concerns. The planning officers shared your concerns.

Meeting reconvened

8.1 Chairman

8.1.1 Bees on Cricket Meadow

We had a swarm of bees on the meadow, by the zip wire. Cllr Sier arranged for a local bee man to come and take them away. It was noted that Cllr Baxter holds bee equipment if a similar problem were to arise.

8.2 Clerk:

8.2.1 Highway matters. To include: 8.2.1.1. Bardwell Road, congestion and parking in Mill Road.

As Cllr Spicer was not able to attend the meeting, due to a prior engagement, the Clerk has already suggested to her that we arrange a site meeting, with residents from Mill Road and Bardwell Road who have expressed concerns over parking around the school. The Clerk is waiting for Cllr Spicer to come back to her regarding this.

8.2.1.2 Drains Hopton Road

This problem has now been rectified.

8.2.2. Sign for cricket meadow & Aggies Piece

The Clerk has contacted SCC about a brown road sign for Aggies. A brown tourist sign carries a £75 application fee plus the cost of design and then the cost of the sign itself. This seems a very expensive option. It was decided to investigate other options. There are 3 signs needed. One on pound corner, for Aggies Piece. One at the entrance to the Cricket Meadow, off Church Road, this sign needs to show the public that they have access to the field and that it is open at all times to the public. And a third one on the B1111 pointing down Sandy Lane towards the children's play area. Permission to erect the signs will need to be sought.

8.2.3 New streetlight, update.

SCC have chased Kier this for an update on this, as they thought the works had been completed. Once they hear back from them they will update us again. The Clerk will continue to chase this.

8.2.4 Gate at play area

The posts on the big metal gate seem to have moved together a bit since installation but they are completely secure. The gate hasn't been closed for years which has probably not helped and means it wasn't noticed sooner. If someone closes the gate it will bolt itself and it is then very difficult to unbolt and probably needs levering open with a crowbar or piece of wood. It should not be closed in this condition. It was agreed that it would be worth sawing the bolt off – if it ever had to be locked in future we could use a chain and padlock. Cllr Baxter will make arrangements to have the bolt removed.

8.2.5 Play area surfacing

The soft surface on the swing unit, which you had re-poured a while ago when the edge started lifting, is lifting badly again and it is only a matter of time before it becomes a trip hazard and dangerous. We will keep an eye on this. The roundabout in the play area is very stiff. The Clerk will ask the caretaker to have a look at this.

I have just had a look at the amended drawings for this application and the only change I can see is a reduction in the height? Although I can't see a height on the original drawing. We were particularly concerned about the big window overlooking Barn View and this doesn't seem to be addressed at all.

The window you are referring to is a landing window. The applicant/ agent has agreed that they would accept this to be obscure, which can be secured by condition.
