6. Report from B. Councillor: C Bull

The Westerly Bridge in Newmarket Road, Bury St Edmunds is to be closed from 13 February to 7 April for major repair work. There will be diversions in place and temporary no waiting restrictions in that area. This is likely to have an impact on traffic in the town as a whole and you need to bear this in mind when travelling into Bury St Edmunds.

Ward councillors throughout Bury St Edmunds now have the opportunity to recognise those who make an outstanding contribution to their communities by awarding a scroll of honour. Cllr Bull will be able to make two awards within the next two years in her Ward. She has put an advert in the Parish News to ask for nominations for this year by the end of September. The next step will be to submit an application to designate a 'Neighbourhood area' The Clerk will work on this and submit it as some as she is able. We will then need to arrange a public meeting. Available dates will be sought from the village hall's booking secretary and a date confirmed at the next Parish Council meeting.
